PARTICIPANT’S WAIVER/RELEASE OF LIABILITY/IMAGE RELEASE

READ BEFORE SIGNING

In consideration of being allowed to participate in any way in American Youth Football, Inc., American Youth Cheer dba, or Plainfield Prowlers Athletic Association, Inc. athletic sports programs, related events and activities, the undersigned acknowledges, appreciates, and agrees that:

- 1) The risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,
- 2) I KNOWINGLY AND **FREELY** ASSUME ALL SUCH RISKS, both known and unknown, **EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES** or others, and assume full responsibility for my participation; and,
- 3) I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and,
- 4) I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, **HEREBY RELEASE AND HOLD HARMLESS** American Youth Football, Inc., American Youth Cheer dba, Plainfield Prowlers Athletic Association, Inc., their officers, officials, agents, and/or employees, other participants, sponsoring agencies, tournament hosts, sponsors, advertisers, and if applicable, owners and leasers of premises used to conduct the event (“RELEASEES”), **WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, TO THE FULLEST EXTENT PERMITTED BY LAW.**
- 5) In addition, my minor child/ward, being allowed to participate in any way in American Youth Football, Inc, American Youth Cheer dba, and Plainfield Prowlers Athletic Association, Inc related events and activities, I, the undersigned, agree that American Youth Football, Inc, American Youth Cheer dba, and Plainfield Prowlers Athletic Association, Inc have the unrestricted and exclusive right and permission, free from approval or review, to copyright and use in all media now or hereafter known, including but not limited to, pictures and videos of my child, which s/he may be included intact or in part, for promotion or other commercial use.

If, despite the release, I, the minor, or anyone on the minor's behalf, makes a claim against any person released, I agree to indemnify and save and hold harmless those released and free each of them from any litigation expenses, attorney fees, loss, liability, damage, or cost they may incur due to the claim, whether the claim is based on the negligence of those released or otherwise.
